Site Plan indicating all property lines / setback distances / North arrow / location of all structures, new and existing with dimensions / driveway location / canals and rivers / roads / size of parcel

Roof or ground layout: A plan view layout of the system and equipment

Line diagram: Detailed line wiring diagram of solar energy system and all electrical equipment

Racking/Mounting: Detailed plans for the racking and mounting equipment and the grounding and bonding for the solar energy system. Include manufacturer specification for fasteners and hardware.

Labelling: In color details of all labels used for the solar energy system and all equipment.

Manufacturer Documents: Manufacturer specifications/cut-sheets for all solar energy system equipment (electrical and structural). Installation manuals are not accepted in lieu of the manufacturer's specification/cut sheets. Exception the manufacturer's specification /cut-sheets are not required if the submitted plans are stamped and signed by an Idaho Licensed electrical and structural engineers.

Engineer Letter: Letter signed by and Idaho Licensed Engineer that the roof will support the load of the solar energy system being installed on it.

#### Minimum 15 business days may be required for plan review
