If creating a new driveway Access Permit (approved) required from Jefferson County Public Works Department if approach is onto a County Road or from Idaho Transportation Department if the access is onto a state highway.

Septic Permit. If there is plumbing in the structure, and if the City Parcel is unable to connect to City of Rigby Sewer system then a Septic Permit (approved) from Eastern Idaho Public Health (EIPH). If connecting to an existing septic system an authorization to connect letter from EIPH.

Must attach copy of active Idaho Contractor License.

Site Plan indicating all property lines / setback distances / easements / North arrow / location of all structures new and existing with dimensions / driveway location / canals and rivers / roads / size of parcel.

Specification sheets for individual Roof Truss and full layout details provided by truss manufacturer. Truss design must be stamped by an Idaho licensed engineer.

Floor system design. Engineered Floor Systems must have correct TJ-Expert or BCI floor designs included with plans.

Footing locations / size and steel requirements / foundation walls dimensions and steel requirements / location of all window and door openings / egress windows / depth of window wells / location of retaining walls if any, and all specifications

All framed walls showing bearing walls / beams / beam sizes / location and width of all doors / window openings / header sizes / all areas where treated plates are required

Floor plans for each floor including basement / information on all room designations / location of smoke and CO detectors. Smoke detectors must be hard wired and interconnected.

All four elevations / front / rear / sides / showing orientation / N. S. E. W.

Building cross sections / showing footing to roof components / footing depth / types of wall coverings / drywall / brick / stucco / etc. / stair cross-section including handrail height / riser height / tread width / headroom / railing height / spacing of spindles / all covered porches / landings / decks / retaining walls over four feet in height

Complete door and window schedule including make, type, size, distance from floor, U-value and any special glazing i.e. tempered, etc.
